Ram Chander Sharma, presently residing at Flat No. 4157, Sector-D, Pocket-4, Vasant Kunj, New Delhi-110 070 and (3) Ms. Shail Pandit daughter of late Sh. Surinder Nath, presently residing at Himalaya Brahma Samaj, The Mall, Shimla-5, the Trustees of the second part:
